◦ **Follow OPD and IPD Duty as per NCISM Norms & below Guidelines**

1. **OPD Duty Compliance**

All doctors are required to perform their OPD duties punctually and diligently, in strict adherence to NCISM norms. Any deviation from prescribed protocols may lead to accountability for resulting complications.

2. **IPD Admissions and Therapies**

Admission of IPD patients and administration of therapies must be conducted as per NCISM guidelines. Any issues arising from unauthorized treatment plans will be the sole responsibility of the concerned doctor.

3. **Leave and Permission Protocol**

If a doctor is unable to attend their scheduled OPD duty, prior intimation and formal permission must be obtained from the HOD & Superintendent or Deputy Superintendent of the hospital.

4. **Intern Responsibilities**

Interns are equally expected to fulfill their OPD duties timely and responsibly. In case of absence, prior approval must be sought from the Superintendent/Deputy Superintendent **and** the Head of Department.

5. RMO , Emergency MO and Concered doctor have to take care of patient emergency.

6. Panchkarma MO have to do their duty as House man in Panchkarma dept as per NCISM norms.

7. Swasthvritt MO have to take care of diet and pathyapathy of patients.
